### Part B. CV SUMMARY

I hold a Ph.D. in Contemporary History (Universidad Autónoma de Madrid, international mention from Columbia University in the City of New York), an M.A. in International Relations and African Studies (Universidad Autónoma de Madrid), and a B.A. in Political Science and Public Administration (Universidad Nacional de Cuyo, Argentina). My research interests revolve around the transdisciplinary intersection of History and International Relations, with a focus on foreign policy, development cooperation and the study of supranational identities. I served as a Postdoctoral Research Fellow at the Katholische Universität Eichstätt-Ingolstadt (Germany) and completed research stays at the Universidade do Estado do Rio de Janeiro (Brazil), Columbia University in the City of New York (USA), Erfurt Universität (Germany), Pontificia Universidade Católica do Rio Grande do Sul (Brazil) and Universidade Federal do Rio Grande do Sul (Brazil). I am fluent in five languages (Spanish, English, German, French and Portuguese) and have published in three of them.



**1. Scientific contributions.** Over the past eight years, my research in disciplines such as Political Science, International Relations, Foreign Policy Analysis and History has consistently focused on the role of identities in societies. In a transdisciplinary dialogue, I've integrated theory, history and analysis to explore various issues. In particular, my pre-doctoral contract at the Universidad Autónoma de Madrid led to the completion of my doctoral thesis in 2021, "La identidad de Brasil como cooperante del Sur: Apogeo y crisis de un modelo de desarrollo alternativo (2003-2016)". As a Margarita Salas Postdoctoral Research Fellow in 2023, I delved into the comparative perspective of "The Rise of the Far Right and Foreign Policy: Brazil and Germany" at the Catholic University of Eichstätt-Ingolstadt. Since January 2024, my role as Juan de la Cierva Postdoctoral Research Fellow at the Escuela de Estudios Hispano-Americanos has allowed me to deepen my research on international identities and social representations within the framework of Utopian Studies.

I am part of three research groups: HISTOPIA (CSIC, Spain); LABMUNDO (UERJ, Brazil); and Grupo de Estudios Africanos e Internacionales – GEA-GERI (UAM, Spain). I have participated in scientific events in many countries in America and Europe and published the results of my research in books, chapters and articles in peer-reviewed journals.

**2. Contributions to society.** In 2016-2017, I dedicated a year to the ERASMUS+ European Voluntary Service programme, working for the State Agency for Political Education of Thuringia. In this role, I focused on popularising literature for the political education of the local population. Since 2020, I have been the editor-in-chief of the journal *Relaciones Internacionales (1699-3950)* at the Universidad Autónoma de Madrid, having previously served as coordinator of the Assessment Committee, coordinator of the Editorial Committee and, since 2016, member of the Editorial Team. I have written and contributed to educational publications for German (LZT), Spanish (Tecnos) and English (Routledge) publishers. I also contribute as an editor to the blogs *Utopia* (<https://utopia.hypotheses.org/>) and *Dictaduras en clave transnational* (<https://dictaduras.hypotheses.org/>), and have been a member of the Universidad Utopia programme on Radio Utopia. Outside of academia, I have worked as an evaluator for SDG cooperation projects at the Alcobendas City Council.

**3. Training of researchers.** As a researcher trainer, I have primarily worked as a lecturer in four universities in Madrid, where I have actively contributed to shaping the academic landscape. In order to improve my skills in this area, I completed the title of Expert in University Teaching Methodologies at the Universidad Autónoma de Madrid (TEMDU UAM). My commitment to fostering research skills extends beyond the classroom through the organisation of academic events, such as my annual participation in the Seminars on the History of International Relations at the Universidad Autónoma de Madrid. Furthermore, my role as a trainer for the journal *Relaciones Internacionales* has provided another avenue for honing these skills. In addition, I have used my expertise to evaluate scientific texts for 10 academic journals and 2 publishing houses.
